ELIGIBILITY: The following are eligible to tender on equal terms: all **Contractors Class I only**, duly registered and licensed to operate in Seychelles. Contractors shall be required to **produce a valid copy of their Contractor's License at the time of purchasing the bidding document**.

PLACE OF PERFORMANCE: Pasquere, Baie St. Anne, Praslin

PERFORMANCE PERIOD: Six (6) Months

ACCESS TO TENDER DOSSIER: The Tender Dossiers can be obtained from the SLTA's Head Office at Dream gate Complex, 1st Floor, Block B and the SLTA Praslin Office at Amitie, Praslin as of **Monday 07th September 2026 from 9:00am to 12:00pm and 1:00pm to 3:00pm** upon payment of a non-refundable fee of **SCR 1' 000.00 each**. The deadline for obtaining the dossier shall be **Friday 11th September 2026 not later than 3:00pm**.

Potential Bidders shall provide a copy of the valid license upon purchase of the tender dossier and shall be allowed to inspect the tender dossier prior to purchase.
